Strong Approximation Schemes for Stochastic Delay Differential Equations

In this talk convergence results for strong approximation schemes for stochastic delay differential equations are presented. In particular we will discuss the Euler-Maruyama method for equations with discrete, variable and distributed time-lag. Numerical experiments illustrate the theoretical results.
